1. Personal data managed and stored on the www.airscan.hu website

When you visit the page, the system automatically collects the necessary data for the operation of the page and the analysis of visits. Data collected includes the following:

- Date and time the page was opened
- Visitor's IP address
- Type and version of the browser used by the visitor
- Type and version of the operating system used by the visitor
- The addresses of the pages opened by the visitor
- The visitor's activity on the site

The aforementioned data is collected and stored by an external service provider called Hotjar for the purpose of improving the operation of the site and analyzing visits. The data manager does not connect the above data with the personal data of the website visitors. The data manager may use the aforementioned data for marketing purposes.

We only collect the personal data of visitors to the site if they provide it voluntarily, for example, if they send a message on the site's message board or if they register on the site. The data manager collects only the personal data that is necessary for the use of the site and that is voluntarily provided by the site's visitors. The data manager will not pass your personal data to third parties, unless the transfer of data is necessary to achieve the data manager's business objectives.

2. Purpose of data management

The data manager uses your personal data for the following purposes:

3. Legal basis for data management

7. The possibility to request the abolition and modification of data

8. Use of cookies

The website www.airscan.hu uses cookies. Cookies are small text files that the site stores on the visitor's computer, and which can be used to optimize the operation of the site. With the help of cookies, the site recognizes the visitor and collects information about the use of the site. You can disable cookies in your browser, but this site may not function properly.
